Dear Parent,

1. I am pleased to inform you that your son/daughter/ward _____, Roll No. _____ has qualified for admission to **Class VI / IX at** this School. Admission is subject to verification of documents (Birth Certificate (proof of age), Category, Caste Certificate, Domicile Certificate etc.) and Medical Fitness. **Your son / daughter /ward presence is mandatory during admission date on at 0830 hrs on _____ May 2020 at Sainik School Bijapur (Karnataka). PARENTS / GUARDIANS ARE REQUIRED TO DROP THEIR WARD ALONG WITH HIS/ HER BELONGINGS AT THE SCHOOL ON THE DAY OF ADMISSION.**

2. Your son / daughter /ward is granted "Provisional Admission" as per inter-se merit amongst **KAR GEN / SC / ST / KAR DEF/ OPEN GEN /OPEN DEF** category. In the case of **SC/ST** candidates, admission is subject to production of "Caste / Category / Domicile Certificate" in the prescribed form as laid down by the Government for the purpose from the Tehsildar of your area. Your son / daughter /ward will not be admitted to the School without "Original Caste Certificate" by the Tehsildar of your Area and the "Birth Certificate" issued by respective Registrar of Birth & Death.

3. Please note that only 'Primary School Leaving Certificate' affixing proper seals of the School and signature of the head of the Institution, in original and Birth Certificate issued by respective Registrar of Birth and Death is to be produced as proof of age or else admission is liable to be cancelled. In case, the date of birth of your son / daughter /ward has been amended with the approval of the competent State Education Authorities, please enclose a copy of the original order.

4. The following documents / forms are required to be completed by you as part of the admission formalities. Specimen copies of the said documents / forms are enclosed herewith as Appendices to this letter. **The printed / cyclostyled specimen copies should not be used for completion of the documents.** They are to be typed on good quality white paper or non-judicial stamp paper as the case may be and completed in all respect. **Photocopying a text matter on Bond Papers / plain paper is not permissible and not acceptable.**

5. FEE DETAILS

Parent is required to submit a Demand Draft in favour of Principal, Sainik School Bijapur for an amount of `1,43,021/- (for General & Defence Category) and `1,41,521/- (for SC/ST), The breakdown of the amount is as follows: -

Note :

(i) **To facilitate the Parents, Fee will be collected in two installments. 60% (first installment) amount will be collected at the time of admission and remaining 40% (second installment) amount will be paid in second term of the academic session i.e. in the month of October / November. If the parent is willing to pay the complete school fees of their ward at a time during admission, the same will be accepted.**

(ii) As per instructions issued by Sainik Schools Society, Ministry of Defence, New Delhi, the school will collect the fee at FULL RATE from ALL THE SCHOLARSHIP HOLDERS during admission, along with the Full Fee paying students.

(iii) In respect of SCHOLARSHIP HOLDERS, fee charged from the parents will be reimbursed on receipt of the scholarship amount from the concerned agencies i.e. Ministry of Defence / Govt. of Karnataka, by adjusting in the student account at the year end & the same will be indicated in the Statement of Account. In the case of cadets from Karnataka, whenever the allowance for dietary supplement is paid by the Govt. of Karnataka, the same will be credited to cadet's account in the year end.

(iv) There is a likelihood of increase in **Tuition Fees** and **Diet Charges** as per instructions received from Sainik Schools Society, Ministry of Defence from time to time.

(v) Payment of fee should be made by Demand Draft only. Payments made by cash or cheque will not be accepted.

(vi) The Statement of Account will be sent to the parents in the month of May every year, indicating the exact amount of fees for the upcoming academic year.

6. Please note that you will be required to pay the Revised Fees, Clothing Charges and Diet Charges as and when increased by the Sainik Schools Society even if it is with retrospective effect and irrespective of the Scholarship Status and Category (viz. SC/ST/Defence and General). **It is brought to your notice that the Tuition fee, Diet Charges and Clothing Charges may be increased as per the directions of Sainik Schools Society each year. This “increase” will be borne by the parents.**

7. **Submission of Documents and Payment of Fee.** Parents are requested to submit the documents as listed above on the dates mentioned at **Annexure-A** without fail. Payment of fee as applicable is to be deposited in the school in the form of Demand Draft, drawn in favour of the **PRINCIPAL, SAINIK SCHOOL BIJAPUR** (State Bank of India, Branch Code No. 03163) on the same day along with the documents.

REOPENING OF SCHOOL / REPORTING TO SCHOOL

8. **ALL PARENTS ARE REQUESTED TO BRING THEIR CHILDREN / WARDS TO REPORT TO THE SCHOOL ALONG WITH THEIR BELONGINGS MENTIONED IN JOINING INSTRUCTIONS ON May 2020 AT 0830 HRS TO HANDOVER TO THE RESPECTIVE HOSTEL SUPDTS / WARDENS ACCORDINGLY.**

9. Please note that if the father of the boy/girl is alive, a guardian cannot sign the documents, bond or affidavit of income etc. If, the father is not alive the mother of the boy should then sign/execute the documents/bonds. A legal guardian may only sign / execute the documents / bonds if the father and mother both are not alive.

10. Please note that the Affidavit of Income, Domicile Certificate, Certificate of Caste and Certificate of Birth are liable to be investigated by the Central Bureau of Investigation / State Police or any other Competent Authority. In case they are found to be incorrect or fabricated, administrative action will be taken to recover the entire Scholarship amount from the parent and the boy/girl will be withdrawn from the School immediately with due legal course of action against the parent.

11. Parents who desire to withdraw their child on any account / for any reason can do so within a period of two weeks from the date of admission of their ward after paying the fee as applicable. No request for withdrawal will be entertained subsequently.

12. Quantum and amount of Scholarship is subject to vary, in case amendments, if any are issued by the competent authorities. Financial benefits / liabilities arising due to such amendments will be passed on to cadet's account /collected from the parent as applicable.

13. **Use of Mobile Phone / Electronic Gadgets** : Use of Mobile Phones and any other electronic Gadget in the school campus, by the cadets (students), is not permitted. In case, Mobile / Electric Gadget is / are caught from the cadets (Students) by the School Authorities, necessary disciplinary action as per Sainik Schools Society, Rules & Regulations 1997 will be initiated, as deemed fit, and they would be liable to pay a sum of `5000/- towards penalty.

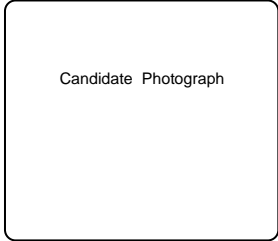
